Outline	The Department of Biological Informatics at the Research Institute for Microbial Diseases, the University of Osaka, comprises multiple laboratories and conducts bioinformatics research on a wide range of biological data. As one of its priority research areas, the department aims to develop bioinformatics technologies that contribute to the control of viral infectious diseases. This research focuses on two main areas: (A) developing AI technologies to predict genotype—phenotype relationships of viral proteins, and (B) establishing efficient computational methods to identify animal viruses with high potential to cause future pandemics. The department is seeking an academic staff member, primarily to work on Project (B), who has a flexible thinking and can contribute to developing and harnessing the strength of the department's research.
